RELEASE OF SPONSORS – The undersigned, being fully aware that participation in the Demolition Derby will expose him/her to a substantial and serious risk of property damage, personal injury or death, hereby release all sponsors from liability for any and all property damage, personal injuries or other claims – including those that are known and unknown, foreseen or unforeseen, future or contingent – arising from the undersigned’s participation in the Demolition Derby.

COVENANT NOT TO SUE – The undersigned covenants that they shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the sponsors; Yuma County Fair Grounds Inc or Demolition Derby committee and volunteers (or their officers, directors, employees, agents or affiliates) concerning, arising out of, or related to the actions causes of action, claims and demands hereby waived, released or discharged by the undersigned.

ASSURANCES – The undersigned has full power, authority, capacity and right without limitations to execute, deliver and perform this release.

BINDING EFFECT – This release shall be binding upon the undersigned and the undersigned’s spouse, legal representatives, heirs, successors and assigns.
